This bill which requires farmers to be certified before they can spread manure or commercial fertilizer will not impact GLSM watershed farmers since they are already certified under their Certified Nutrient Management Plans. (CNMP's) Jim fielded some questions including one from a farmer who had been accused of applying manure outside the rules. The farmer was found to have complied completely with the rules and was wondering how such false accusations could be stopped. No one including Mr. Buchy had a truly workable answer.

OLD BUSINESS:

NKTelco Update

The severe winter we experienced played havoc with NKTelco’s installation plans but with the break in the weather, they are burying conduit along SR 716 north from Maria Stein to Chickasaw. A shortage of fiber optic cable is also impacting their schedule. To make use of previously buried undersized conduit they had to order 12,000 feet of special fiber causing additional delays. The company is still optimistic that they can begin providing service by midsummer.

INDUSTRIAL PARK EXPANSION

The township trustees, legal counsel, Ron Puthoff and Jared Ebbing joined the MCDO in the later part of the meeting. After considerable discussion the group all agreed that the MCDO will be the entity purchasing the land from Pat and Nancy Nieberding and reselling the lots. The MCDO board had previously passed a motion agreeing to perform this service. The MCDO will use any money remaining after all transactions are complete to reduce the Tax Increment Financing (TIF) loan. This will be most beneficial for entities such as the school, that rely on tax income. We have strong to super strong commitments from businesses to purchase all 10 lots in the development making this a very positive development for our community. Thanks a ton to Ron Puthoff and Jared Ebbing who spearheaded this project. They did a great job!
