HEALTH, SAFETY & EDUCATION

March is National Workplace Eye Wellness Month. Many people spend several hours a week working on computers, here are a few answers to common questions dealing with eye health while at work.

- Can looking at computer screens damage my eyes?
 - No, it does not damage the eyes. Complaints of eye fatigue and discomfort are common among computer users, these symptoms are not caused by the computer screen itself.
- Can looking at the computer screen cause eyestrain?
 - Fatigue, dry eyes, bad lighting, or how you sit in front of the computer can cause eyestrain. Symptoms of eyestrain include sore or irritated eyes and difficulty focusing. You may also have symptoms of eyestrain if you need glasses.
- What can I do to prevent eyestrain?
 - Place your screen 20 to 26 inches away from your eyes and a little bit below eye level.
 - Use a document holder placed next to your computer screen. It should be close enough so you don't have to swing your head back and forth or constantly change your focus.
 - Change your lighting to lower glare and harsh reflections.
 - Get a chair that can be adjusted to the correct height for your computer station.
 - Choose screens that can tilt and swivel. A keyboard that you can adjust is also helpful.
