## NKTelco Update

As of August 6, the crew finalizing the conduit installation phase of the NKTelco project advised that the special order fiber optic cable still has not arrived. NKTelco General Manager, Preston Meyer attended the Industrial Park groundbreaking ceremony and informed us that they continue to expedite this cable and will be installing it as soon as it arrives.

## INDUSTRIAL PARK EXPANSION

The Industrial Park Expansion has sold all of the ten (10) available lots in the Phase III Expansion. The buyers and the MCDO have closed on 7 of the 10 lots with the $8^{\text {th }}$ lot closing on August 14. Revenue from the closings on these 8 lots is sufficient to cover the loan costs plus all expenses incurred to date. The owners of the lots that have closed are as follows:

The MCDO has been directed by the EPA to seed all of the land in the Phase III area because of soil erosion and run off concerns. Bob Unrast is working to contract this project as economically as possible. We do not like to incur this expense however with a directive from the EPA we have little choice. After discussion, Elaine Wolters made a motion to approve this project. Jean Bender seconded the motion which was approved unanimously.

The Groundbreaking Ceremony for the Phase III Expansion held on July 31, 2014 went very well. Attending were the Mercer County Commissioners and representatives from the County Economic Development Office, Park property owners, the Osgood State Bank, Midwest Electric, NKTelco, and the MCDO board. Local TV stations covered a brief shovel ceremony in the park after which the group gathered for lunch in the Township Building. There the Township Trustees and the MCDO thanked all the many people who worked diligently to make this expansion a reality.
