As a follow up to his December 2, Ag Solutions presentation, Glen Arnold conducted a luncheon meeting at the Korner Kafe on December 20. At this meeting, Glen, who is a nutrient applications specialist residing in Putnam county, shared the results of local tests plots to the farmers who provided the test sites. For a number of years he has been conducting tests in which liquid dairy or swine (primarily) manure is applied to growing crops. The results have been positive and Glen is planning additional trials during the 2014 growing season. The 2013 plots discussed at the December 20<sup>th</sup> meeting reflect Glen's first trials in the watershed.
