HEALTH, SAFETY & EDUCATION

Emergency aid for burns:

- Put out the flames, (stop, drop & roll) or cover the flames with a non-flammable blanket or coat.
- Call for emergency help if the person has any difficulty breathing.
- Brush off chemicals (do not use your bare hands to do this) then wash off the chemicals.
- Cool the burnt area for at least 20 minutes under cool running tap water (do not use ice).
- Cover the burn with cling wrap or burn dressing.
- Do not put any creams or other treatments on the burns until they have been seen by a doctor.
- Burns can become infected easily, and they can leave scarring, so unless very small, have the burn evaluated by a doctor.

AGRICULTURAL DEVELOPMENT

Kara Uhlenhake is the new Ag Education teacher/FFA coordinator at Marion Local. Jim Keller and Shannon Everman are meeting with her on Tuesday, September 10, 2014 to discuss the MCDO and FFA relationship and the services provided to the FFA.

All are welcome at the monthly Ag Boosters meeting which is held at 8pm on the third Monday of the month in the Marion Local Ag Ed classroom. The next meeting will be held on September 15.

Ag Solutions conducted a meeting on September 8th at the Chickasaw Library. Heidelberg University presented a report on the phosphorus levels entering the lake through several area creeks, including the Chickasaw and Coldwater Creeks. Heidelberg has been monitoring these levels for a number of years. Ag Solutions meetings are open to anyone wanting to attend.

OLD BUSINESS:

The MCDO Website is almost complete! Officials and Board Members of all organizations in the community have been updated with contact information. MCDO meeting minutes and quarterly newsletters will be posted on the site. Any organization desiring to have their minutes or other information posted can do so by contacting us. Additionally, a brief history/background about each of the organizations has been included. We have 16 pages of community

businesses that must be updated to provide the most current contact information. These updates are now complete. Final review of the website "click thru's" and links are underway.

NEW BUSINESS:

Mark Seitz, Chickasaw Fire Chief, was present to discuss the impact of the new water system project in Chickasaw and the Industrial Park Expansion to the Chickasaw Fire Department and area homeowners. The Fire Department is rated by the Insurance Services Office, which affects the insurance rates of homeowners within the fire district. There is concern of the lack of water supply within the Marion Township Fire District. Mark intends to work with each project team to incorporate water lines and hydrants in the Industrial Park to avoid a lack of water supply.

NKTelco Update

NKTelco has been moving forward within the Marion Community. They have been working through the town recently pulling cable and making some progress.

INDUSTRIAL PARK EXPANSION

The MCDO is working with the Marion Township Trustees, legal counsel, and Jared Ebbing to finalize all expenses for the Industrial Park Expansion Project. Once all of the items have been finalized, the MCDO will use the remaining funds from the project to pay down the Tax Increment Financing (TIF) loan. This will be most beneficial for entities such as the school, which rely on tax income.
