#### February is American Heart Month

Heart Disease kills an estimated 600,000 Americans each year and remains the leading cause of death for both men and women.

- What is Heart Disease? A disorder of the blood vessels of the heart in which a waxy substance (plaque) builds up in the coronary arteries.
- Risk Factors for Heart Disease: Smoking, high blood pressure, high cholesterol, overweight, physically inactive, unhealthy diet, diabetes or pre-diabetes, and metabolic syndrome.
- Lifestyle changes that can help prevent heart disease: Kick the smoking habit, eat for health (lean meats, fruits and vegetables, low fat dairy, whole grains), move more, aim for a healthy weight.
- The good news: Heart disease can be prevented when people make healthy choices and manage their health conditions.

Communities, health professionals, and families can work together to create opportunities for people to make healthier choices. Spread the word about strategies for preventing heart disease and encourage people to live heart healthy lives.

### AGRICULTURAL DEVELOPMENT

All are welcome at the monthly Ag Boosters meeting which is held at 8pm on the third Monday of the month in the Marion Local Ag Ed classroom. The next meeting will be held on February 16, 2015.

Ag Solutions held a meeting on February 2, 2015. Jim Hoorman, Assistant Professor of Agriculture and Natural Resources at The Ohio State University spoke and answered questions at the meeting for over an hour. Jim focused on how phosphorous leaches out of our fields and what steps can be taken to reduce the loss.

Phosphorous loss can best be minimized by increasing Soil Organic Manner (SOM).
SOM can best be increased by using a combination of cover crops and no-till practices which closely imitate
the way Mother Nature works.
The best cover crops are the grasses since they significantly increase SOM. Jim especially recommended
Sorghum Sudangrass. He mentioned a GLSM dairy farmer who has used it for a number of years now to
great benefit. It really loosens the soil and increases organic matter. He was not enthusiastic about radishes
unless used in concert with grasses. Grasses that survive the winter are important for this watershed.

Dr. Larry Brown, Professor of Food, Agriculture, and Environmental Sciences at the Ohio State University has also encouraged area Ag Members to attend the Overholt Drainage School to be held March 16-20, 2015 in Defiance, Ohio.
