Monitoring Added Sugar In The Foods We Eat May Lead To Better Health

Up to 75 percent of packaged foods, including breakfast cereals, granola bars, flavored yogurts (even the fruit flavored varieties), soups, breads and condiments, contain added sugars, causing us to take in excessive amounts of sugar on a daily basis. The average American consumes almost 20 teaspoons of sugar per day. The American Heart Association advises that the total amount of added sugars in your diet to not exceed 6 teaspoons (25 grams) per day for women and 9 teaspoons (36 grams) for men.

It doesn't take a medical expert to recognize that this amount of sugar may be very damaging to your overall health. Over time, added sugars can mess up your metabolism, cause weight gain, raise the risk of heart disease, diabetes, and tooth decay.

Natural sugars are found in foods like yogurt, milk and fruits, and they don't lead to the same health problems that added sugars do. The one exception to this is fruit juice. Juice lacks the fiber contained in fruit. The recommended amount of fruit juice per day is one cup.

To eliminate added sugars, you first need to find them. Sugar sweetened drinks are the leading source of added sugars in our diet. Replacing sugary drinks with water or an unsweetened beverage is a better choice. Sugar goes by many different names including cane sugar, brown sugar, fruit juice concentrate etc. Until the updated labels make it to the shelves (reportedly 2020), you'll have to make the best of it by comparing one product to a similar product, looking at the Nutrition Facts label at the grams of sugar per serving to find foods with the lowest levels.

A recommended recourse on how to read food labels is ChooseMyPlate.gov made available thru the United States Department of Agriculture (USDA).
