HEALTH, SAFETY, & EDUCATION

With the holidays around the corner, it is important to have your health in tip-top shape so you can spend time with family and friends. The last thing you want to worry about is catching or spreading illnesses such as the cold or flu to a family member or friend.

Illness-causing bacteria can survive in many places around your kitchen, including your hands, utensils, and cutting boards. Unless you wash your hands, utensils, and surfaces the right way, you could spread bacteria to your food, and your family.

Wash your hands the right way-for 20 seconds with plain soap and water. Make sure to scrub the backs of your hands, between your fingers, and under your nails. Wash your hands before eating, before and after food preparation, after handling uncooked eggs, raw meat, or seafood and also after touching an animal or pet.

Wash surfaces and utensils after each use. Use paper towels or clean cloths to wipe kitchen surfaces or spills. Wash cloths often in the hot cycle of your wash machine. Wash cutting boards, dishes, utensils, and counter tops with hot soapy water after preparing each food item and before you go on to prepare the next item.

Wash fruits and veggies-but not meat, poultry, or eggs. Even if you plan to peel fruits and veggies-it's important to wash them first because bacteria can spread from the outside to the inside as you cut or peel them. Washing raw meat and poultry can actually help bacteria spread, because their juices may splash onto (and contaminate) your sink and countertops. All commercial eggs are washed before sale. Any extra handling of the eggs, such as washing, may actually increase the risk of cross-contamination, especially if the shell becomes cracked.

If you follow these tips you are bound to have a happy and healthy holiday season!

OLD BUSINESS:

Nick Moeller provided an update on the Marion Community Multi-Use Path Project. The Committee plans to host the event again in 2019 and more information will be provided on dates in the near future. The next meeting is scheduled for Tuesday, November 27th, 2018 at 8:00 p.m. at the Moeller Brew Barn.

The MCDO is continuing to review the feasibility of natural gas in the community. A data request was sent to all Marion Community businesses in September to estimate the potential demand of natural gas in the area. The MCDO is trying to see if there is a different and easier approach to obtaining the data usage for the feasibility study. More information will be provided as it becomes available. The State Route 716 Sidewalk Project is still being reviewed and pursued. Some questions concerning crosswalks to school, drainage and sidewalk width were submitted to ODOT. We just received answers to the questions and are currently reviewing them.

NEW BUSINESS:

The MCDO was approached by Energy Alliances, an energy consulting and supply company, to determine any potential savings opportunities for the Marion Community. Energy Alliances will negotiate with electric suppliers for aggregated savings and could potentially assist in the natural gas feasibility study. A meeting with Energy Alliances will be set up. This meeting will include a representative from the trustees, MCDO and Energy Alliances.

One of the CD's has reached its maturity, and the Board decided to renew the CD for 25 months with Osgood State Bank. Don Rosenbeck moved to approved the renewal. Jean Bender seconded the motion which was approved unanimously.

The MCDO is excited to announce that the Marion Industrial Park is expanding! A group of investors formed Marion Community Land Development, LLC and has recently purchased 80 acres to the North of the existing Industrial Park.
