9 Things to Know Before You Donate Blood in 2019

January is National Blood Donor Month. It's also a difficult time of year to collect blood donations due to inclimate weather and the flu season. To help prepare for your blood donation, the Red Cross has nine tips to know before donating blood in 2019.

- 1. Your whole blood donation appointment will take approximately one hour. In the time it takes to complete one whole blood donation appointment, 1,800 patients in the U.S. will have needed lifesaving products. To make your donation more comfortable, come prepared. Be sure to wear a top with sleeves that can be rolled-up easily and something to read.
- 2. You don't need to know your blood type. According to a national survey conducted in April 2018, on behalf of the Red Cross, more than 53 percent of people believe they need to know their blood type to donate blood- this is simply not true.
- 3. You must be in good health. Seasonal illnesses like the flu can affect a blood donor's ability to give. Most medication will not disqualify you from being able to donate, but if you have questions please visit RedCrossBlood.org.
- 4. Rest and relax. Get a good night's sleep before your donation and avoid any heavy lifting or strenuous activity afterwards. If you experience dizziness or lightheadedness, stop what you're doing and sit or lie down until you feel better.
- 5. Hydrate and eat a healthy meal before your donation. It is important that before giving blood, donors drink plenty of fluids (an extra four 8-ounce glasses of fluids) and eat nutritious foods, rich in iron and vitamin C such as red meat, fish, poultry, beans, spinach, iron-fortified cereals or raisins.
- 6. You're never too old to donate blood. While in most states, you must be at least 17 years old to donate blood, there is no upper age limit. In fact, many elderly individuals are some of the most dedicated blood donors.
- 7. Speed up your donation by completing a RapidPass online health history questionnaire. RapidPass can also be completed on mobile devices, through the Red Cross Blood Donor App.
- 8. Don't forget your Free post-donation snack. Blood contains many substances including red blood cells, white blood cells, plasma and platelets, plus water and various nutrients and minerals, which is why it is critical that donors replenish their bodies with post-donation snacks and fluids.
- 9. Scheduling a blood donation appointment is easy! All eligible individuals can make an appointment by using the free Red Cross Blood Donor App, visiting RedCrossBlood.org or calling 1-800-REDCROSS (1-800-733-2767).

AGRICULTURAL DEVELOPMENT

The Ag Ed Boosters will be hosting Ben Brown, Ohio State University Program Director of Farm Management on Tuesday, January 22nd, 2019 at 7:30 p.m. at the Maria Stein American Legion Hall. The topic will focus on emerging issues in today's farm economy. The event is open to the Marion Local and surrounding communities. Youth with an interest in agriculture are encouraged to attend.

There will be a Farm Succession and Transition Workshop held on January 30th, 2019 from 9:30 a.m. to 4:00 p.m. at Romers in Celina. The event is sponsored by the OSU Extension Agricultural Program and is designed to help farm families develop a succession plan for their farm business. Guest speakers include: Robert Moore, Attorney; Peggy Hall, Assistant Professor OSU Extension Agricultural &

OLD BUSINESS:

Nick Moeller provided an update on the Marion Community Greenway Project. There will be a public meeting held on Tuesday, January 15th, 2019 at 7:00 p.m. in the Marion Township Building. Updates will be provided on the multi-use path and application process. The application is due for local review on January 15th, 2019. If you are interested in providing a letter of support in favor of the bike path, please address your letter "To Whom It May Concern" and it can be given to Nick Moeller prior to January 15th. The grant would fund 76% of the project, which is approximately \$866,000. The Committee has received commitment letters to fund \$144,000 of the \$304,000 local match required. The MCDO has agreed to be the supporting organization to coordinate the flow of funds on a loan for the remaining local amount required on the project. Elaine Wolters moved to approve the MCDO as a supporting organization. Bob Unrast seconded the motion which was approved unanimously.

The MCDO is continuing to review the feasibility of natural gas in the community. The MCDO was approached by Energy Alliances, an energy consulting and supply company, to determine any potential savings opportunities for the Marion Community. Energy Alliances will negotiate with electric suppliers for aggregated savings and could potentially assist in the natural gas feasibility study. A meeting with Energy Alliances was held on January 9th, 2019 and included a representative from the trustees, MCDO and Energy Alliances. More information will be provided as it becomes available. The State Route 716 Sidewalk Project is still being reviewed and pursued. Some questions concerning crosswalks to school, drainage and sidewalk width were submitted to ODOT. We just received answers to the questions and are currently reviewing them.
