Splash into summer with 6 essential pool safety tips!

Is there anything better than spending the sizzling dog days of summer splashing in a pool? Whether at your home, a friend's house or a community pool, swimming is a wonderful way for families to bond and make the most of the hot weather, but it's important not to let the fun overshadow important water safety guidelines.

Drowning is the leading cause of unintentional death among children ages 1 to 4-years old. According to new data released by the U.S. Consumer Product Safety Commission, fatal drownings in the United States are on the rise, with an average of nearly 1 child per day involving children younger than 15 years old each year. As temperatures soar, remember to follow these six important steps while spending time in and around the water.

- Teach children how to swim. When children learn how to swim, they become more comfortable around water and understand important safety rules.
- Never leave a child unattended. If you need to leave, even for a moment ask another adult to watch your child while you're gone.
- Teach children to stay away from drains. Children's hair, limbs or bathing suits can get stuck in a drain.
- Ask about drain covers. Be proactive and ask to confirm that all pools you visit have adequate drain covers.
- Install proper barriers. If you have a pool or pond, it's important to install proper fences to keep unsupervised children away from accessing the water.
- Learn CPR. Bystanders are often the first to aid a drowning victim, so learning CPR on children and adults can help prepare you to save a life.

These six steps will help you keep your family safer, so you can enjoy the best summer by the pool.

The Natural Resources Assistance Council (NRAC) District 13, has approved for funding the Marion Township Greenway project with a grant for \$869,500. The Marion Township Greenway project will require local funds of \$305,500. With many generous donations already pledged, local funds committed have reached over \$154,000. This project would not be possible without the generosity and support of many organizations, businesses and people, all which help make this community incredible!

The Marion Community Multi-Use Path committee volunteers are preparing the Marion Township Greenway Founders' Brick Club pledge program.
