Mercer Health Visitor Policy

To ensure the health and safety of patients, their families and staff, Mercer Health has implemented the following guidelines.

- All visitors of Mercer Health will be subject to screening upon entrance to the facility.
- Visitors will be required to wear a mask at all times. There are no exceptions.
- Visitors are encouraged to stay in the room with the patient when possible.
- No visitors under the age of 18, with the exception of immediate household siblings in the Childbirth Center.
- No visitors are allowed in the hospital from 6PM 7AM, unless accompanying an emergency room, maternity, or pediatric patient.
- Visitors must check out at the screening desk prior to departure.

Entrance

- Visitors should enter on the west side of the hospital by using Entrance #3: West Entrance or Entrance #2: South Entrance.
- Entrance #1: ED Entrance all patients/ visitors will be stopped near registration desk for screening.
- Entrance #4: Remains closed to the public.
