The Ag Solutions projects are progressing well. They currently have a two-stage ditch under construction, along with completion of several acres of grassed waterway and two cascading waterways, several wetlands with private landowners, and Phase 2 at Mercer Wildlife Area is completed (see picture). They received the Army Corps permit for the Chickasaw Creek Wetland project and the next step is for the contractor to begin. Theresa Dirksen is also working on another two-stage ditch grant application. Finally, the Agriculture Nutrient Policy Council is planning to tour the GLSM area next week.
