#### AGRICULTURAL DEVELOPMENT

#### Committee Chairperson – Mark Hardesty

Mark Hardesty provided an update on the FFA and Agriculture & Natural Resources (ANR). Currently lake level is still below normal pool elevation, but it should rise as we get more spring rains. There was no drawdown of lake level this year due to the drought last fall.

The Lake Facilitates Authority has a wetland project currently out for bid for the Northshore Greenspace and Rosenbeck Nature Preserve Wetlands. These wetland projects will be under construction during summer/fall 2024. The LFA was also recently awarded another Clean Ohio grant to purchase 16.5 acres directly adjacent to the GLSM State Park in Auglaize County.

The Conservation Drainage Network (researchers from Iowa, Illinois, Indiana, Ohio and Michigan) will be meeting in Ohio in early April. They will be hearing from Theresa Dirksen about different drainage and edge of field practices in Mercer County and they will also be touring a few projects in Mercer County.

Theresa Dirksen is also giving a talk at the Norton Engineering Stormwater Seminar in late March and speaking with the Farm Bureau Leadership program in April.

ANR is continually making improvements at the existing wetland projects to repair pumps and maximize efficiency at each site. ANR will have a drive-it-yourself tour planned for May 4, so look for more details on that in the near future

The Marion Local FFA recently held National FFA Week which was very busy with activities. The FFA Banquet was held on Thursday, March 14 at the Harvest Barn. Several volunteers kept watch during the tornadoes and bad weather that night and kept the students and visitors safe! The Ag Boosters along with New Bremen will be touring the East Creek facility on 274. The Strawberry Sales were a success and the FFA recently participated in the Dairy and Livestock Judging Days. The State Convention will be held on May 2-3, 2024 and there are potential for students to earn 2 American Degrees and 3 State Degrees.
