8. Marion Local Schools –Ryan Goldschmidt presented the financial forecast to the Board of Education showing the fiscal outlook over the next 5 years. While the outlook is very promising and stable, there is a lot of concern over the ongoing state budget and property tax reform that is taking place in Ohio. Currently, there are numerous bills and legislation in process that would totally reform the way taxes are collected locally, and it would have significant impact on the Marion Local School District. Some of the main topics at hand include the elimination of certain types of levies including emergency levies and adding fixed sum levies to the 20-mill floor. This would have a large impact on the Marion Local School District as it would essentially eliminate a current levy that we have which provides \$1,200,000 to the school district annually. This would put the school district in the position to have deficit spending as early as 2029. These two main changes along with many others being talked about not only would cause concern for the school district but would actually push even more of the school financing burden from the state to the local taxpayers. While touting it as tax relief, it could actually cause more levies to be brought to the table much more often. It is important that the local community stay aware of these changes and continue to push for the full funding of our public schools, which are the heartbeat of our communities!!

The meeting was adjourned at 8:25 am with a motion from Allison Moeller and a 2nd from Jean Bender. The next MCDO meeting is scheduled for Tuesday, November 18th, 2025, at 7:30 a.m. in the Marion Township Building.
